CALL TO ORDER

Meeting was called to order by Chair, Dr. Alfred Martin at 10:11 a.m.

APPROVAL OF MINUTES

Minutes from July 14, 2017 were read. Katrina Phillips moved that the minutes be accepted and Gloria Salters second.

New Travel Requirement – Jackie Ledger advised the committee that the optimizer for the new travel requirements has been revised. Ms. Ledger states she will send complete authorization and optimizer to SAG members prior to each meeting. She also stated that she needs the pre authorization from members at least two weeks before the scheduled meeting.

2018 JJ Symposium – Extension for approval of funds through September 30. The drop

dead date is September 30 then close out by December 30, 2017. No expenditures after September 30, 2017 (\$88,500).

Dr. Martin talked about a National Opioid Conference with national speakers. Jackie Ledger then reminded the committee to stick with the purpose area to ensure that OJJDP/DPS funds pay for conference.

Possible dates for conference includes: July 31, 2018-August 3, 2018 or August 8, 2018-August 10, 2018.

Compliance Update – Anslem Palmer reported that DPS is working on getting corrections to DOJ by March 30, 2018. Dr. Martin stated that some of the SAG members will try to meet prior to next scheduled SAG meeting to address concerns.

New and Old Business

OJJDP UPDATE – Dr. Martin reported that SAG Chairs attended meeting in Washington, DC to meet with OJJDP. The current Director of OJJDP would like for the SAG committee to be a part of the three year planning application of intent to remain as well as compliance. Jackie Ledger sent the three year plan to Dr. Martin and asked committee to take time to review the three year plan.

After reviewing the three year plan, Gloria Salters indicated that it appears the three year plan's narrative is outdated. Jackie Ledger stated that she will review and report to committee at next meeting.

Dr. Martin also states the following was discussed in Washington, DC:
Need for youth participation; If SAG Committees do not have youth participation, OJJDP will stop releasing funds. Dr. Martin asked members to submit possible Youth SAG Members and reminded the committee that the youth names that are submitted must have juvenile justice involvement.

COMMITTEE REPORTS UPDATES

PUBLIC RELATIONS – It was suggested that the SAG Committee look at FaceBook and Twitter for the 2018 JJ Conference. Billy Talley gave presentation on Teleconnect in reference to public relations for the 2018 MS. JJ Conference

DMC – Mississippi is in compliance. SL&G 2015 – No awards made. DPS will look at what we have and report to SAG at next meeting.

JDAI – Gloria Salters reported that JDAI is changing directions and more specific driven. JDAI will choose the states that are actually doing the work by JDAI criteria and fund these states. Ms. Salters reported that JDAI will continue to work with Mississippi.

Dr. Martin asked Ms. Salters if Rankin County will be part of the case process and initiatives and it was reported that Rankin County will be part of this process and will be considered a resource court.

JDAI is currently under the AG's Office.
